



Active Patent Litigation Disputes (left) and IPR Petitions (right) Quarterly



Most PTAB Patents Are Litigated but Not Vice Versa





Institution and Final Decision Rates: at least some claims instituted or ruled unpatentable, respectively





New Patent Litigation Disputes Filed Weekly in US District Court





By defendants added in 2017. TC Heartland decision occurred May 22, 2017



Cases Transferred From Districts After TC Heartland







Cases Transferred Into Districts After TC Heartland



Active Patent Cases in Delaware by Assigned Judge





New Patent Litigation Disputes Filed Annually in US District Court



Active Patent Litigation Disputes in US District Court Quarterly



Patents Offered To RPX for Purchase in Open Market



Defendant Costs To Resolve Individual NPE Litigations in US




